Who are Ralston's anti-solar groups?

Ralston's group is one of many anti-solar organizationsemerging to oppose what they say are mammoth projects. They argue that these projects do not fit the character of their communities and should be confined to industrial zoned land, not land for agriculture. Ralston and his groups are not against solar energyper se.

How many anti-wind groups are there?

The rise in anti-wind groups can be seen by the surging number of such groups on Facebook. One estimate I have seen shows that the number of anti-windgroups has more than tripled since 2018 and now totals several dozen.

Is a nonprofit group using false propaganda to stop solar projects?

An investigation by NPR and Floodlight into a nonprofit group using false propaganda to stop rural solar energy projects across the US is a must-read. The story, by Floodlight's Miranda Green and NPR's Michael Copley, is about Citizens for Responsible Solar, a group that was started in 2019.

How does citizens for responsible solar Stoke opposition to solar projects?

Analysts who follow the industry say Citizens for Responsible Solar stokes opposition to solar projects by spreading misinformation online about health and environmental risks. The group's website says solar requires too much land for "unreliable energy," ignoring data showing power grids can run dependably on lots of renewables.

Which solar projects have been rejected or withdrawn?

Among those solar projects: In Pennsylvania, Nevada, and Montana, projects were rejected or withdrawn after facing fierce local opposition. The latest rejections include two large proposed solar projects in Henry County, Virginia, which were rejected in November.

How did grassroots activists stop solar projects in Ralston?

Many grassroots activists today credit their success in stopping solar projects to Ralston. One of them is Kathy Webb. Webb says she learned that a company wanted to clear a forest for a solar plant near her home in Rowan County, N.C., days before local officials planned to vote.

As we continue our analysis of the secretive "Citizens for Responsible Solar" group, we debunk their arguments against solar power. Anti-Solar Network.
