Aksa Energy's current global projects include a 430MW natural gas power plant in Talimarjan, Uzbekistan, a 240MW heat and power plant in Kyzylorda, Kazakhstan, a 350MW natural gas power plant in Kumasi, Ghana, and a 255MW natural gas power plant in Saint Louis, Senegal.

What is Aksa energy's power purchase agreement with Societe Jiro sy rano malagas?

In 2018,Aksa Energy signed a power purchase agreement with Societe Jiro Sy Rano Malagasy (Jirama) for the rehabilitation and operation of a 24 MW power plant located next to Madagascar Heavy Fuel Oil Power Plant. According to the agreement,electricity generated by the power plant is being sold to Jirama via guaranteed sales in US dollars.

Which countries did Aksa Energy Invest in?

Following its successful investments in Africa,Aksa Energy entered Asia with Uzbekistaninvestment. Aksa Energy continues to diversify its portfolio geographically with Tashkent and Bukhara natural gas combined cycle power plants which will have a total installed capacity of 740 MW.

Aksa Energy participated in the leadership race among the most important installed electrical power companies with Ali Metin Kazanci Antalya Natural Gas Fired Combined Cycle Power Plant beginning to operate in 2008.
