Formed from other energy agencies after the 1973 energy crisis, EERE is led by the Assistant Secretary of Energy Efficiency and Renewable Energy (Assistant Secretary), who is appointed by the president of the United States and confirmed by the U.S. Senate. Alejandro Moreno currently leads the office as the Acting Assistant Secretary.

The Principal Deputy Assistant Secretary (PDAS) is responsible for supporting EERE's Assistant Secretary in leading the organization. In this role, the Office of the PDAS oversees the External Affairs teams, who work to increase the overall effectiveness and impact of all EERE activities.
