To corroborate these cost estimates, the Energy Commission also examined cost data from the Solar Energy Industries Association (SEIA). The California Energy Commission adopted the 2025 updates to California's Building Energy Efficiency Standards (Energy Code). The Code update is estimated to save \$4.8 billion in energy costs, reduce greenhouse gas emissions by about 4 million metric tons, and make homes and buildings more climate-resilient and comfortable.
