On July 5, CITIC Press Group Corporation ("CITIC Press") successfully debuted on the A-share market and was officially listed on the Shenzhen Stock Exchange. The company's shares are referred to as "CITIC Press" (stock code: "300788"), with an IPO of 47.5379 million shares at a price of RMB 14.85 per share.

CITIC Limited, through CITIC Pacific Energy Investment, invests in and manages power plants on Chinese mainland, with a total installed capacity of over 6.4 million kilowatts. Among them, Ligang Power plant in Jiangsu Province is one of the largest coal-fired power plants in China, with an installed capacity of 4.04 million kilowatts.

As of now, CITIC has yet to officially decide whether it will retain its stake in Alumina Ltd. or sell its shares in exchange for Alcoa stock.
