Vision Solar also allegedly failed to successfully complete the permit requirements in setting up consumers' solar grids, resulting in unexpected fines or liens for the customers.

#### Did vision solar sell solar panels to consumers?

Vision Solar sold solar panel systems to hundreds of consumers, allegedly promising certain solar-energy benefits and fast timelines for project completion. Consumers instead reported experiencing extensive delays, damage, and empty promises.
