In a recent decision in Power Mech Projects Ltd. v. Doosan Power Systems India Pvt. Ltd. 1, the High Court of Delhi reiterated the legal position that a Court acting under Sections 29A(4) and 29A(5) of the Arbitration and Conciliation Act, 1996 ("Arbitration Act"), may extend the mandate of the arbitral tribunal either prior to or after the expiry of such mandate.

In a recent ruling in Power Mech Projects Ltd. v. Doosan Power Systems India Pvt. Ltd., the High Court of Delhi reaffirmed the legal stance that under Sections 29A (4) and 29A (5) of the Arbitration and Conciliation Act, 1996 ("A& C Act"), a Court has the authority to extend the mandate of the arbitral tribunal, whether before or after the mandate"s expiration.
