

How many GWh of energy storage is needed in 2025?

To maintain grid stability, TERNA forecasts the need for 71GWh of storage, equivalent to about 20GW of capacity by 2030. Does Italy need a long-duration energy storage system?

Local industry contacts and U.S. companies in the sector have indicated to CS Italy a need for long-duration energy-storage solutions. As of April 2023, Italy had more than 300,000 storage systems, with a total power of about 2,350 MW and a maximum capacity of about 4,000 MWh.

How much energy storage will Europe have in 2020?

In 2020, the European storage capacity amounted to 40 GW. Those are not binding targets, Ease said. The European Commission's proposal to update the EU's renewables directive, which also includes energy storage technologies, is expected on 14 July as part of its Fit for 55 package.
