Why are solar panels being sued?

Today's legal actions are the result of the Attorney General's Consumer Protection Division investigations revealing the companies misled consumers about solar panel system installation processes, misrepresented pricing and incentives, and in some cases, caused damage to customers' property.

Is the solar industry in trouble?

Residential solar representatives dispute the claim that the industry is in trouble; though installations will decline in 2024, the number of homes with rooftop solar will increase from 4 million today to 10 million by 2030, according to Stephanie Bosh, vice president of communications for the Solar Energy Industries Association.

What happens when a solar company goes offline?

When a solar company goes offline, capacity comes offline, meaning less-efficient companies are closing down. Here's an incomplete list of solar firms that have closed down, either by closure, bankruptcy, or fire-sale acquisition:
