The project aims to increase Grenada''s reliance on renewable energy and reduce its dependence on fossil fuels. Rodriguez highlighted concerns about the fire detection provisions in the 2023 edition of the NFPA 855 standard for the installation of stationary energy storage systems and the 2021 edition of the International Fire Code (IFC). These fire code provisions do not define conditioned and unconditioned space.

Previously, Roger Lin at NEC"s Energy Solutions division has told Energy-Storage.news of his role on the standards committee at NFPA, commenting that "there"s a lot of great stuff in there [NFPA 855]," including "seemingly trivial" considerations that can end up causing serious problems.

While the publicly traded company said in its announcement that the fire incident which began at around 7:45pm local time was "minor" and involved a "low intensity fire", broadcaster ABC said police had urged nearby residents to "stay indoors and keep respiratory medication close by".. The ABC report noted officers said hazardous smoke was spread ...

These battery energy storage systems usually incorporate large-scale lithium-ion battery installations to store energy for short periods. The systems are brought online during periods of low energy production and/or high demand. A statement acknowledged that fires at energy storage facilities are "exceedingly rare," but New York has been subjected to three such incidents in the past few months: East Hampton Energy Storage Center (EHESC) on Long Island suffered an "isolated fire" in May, followed in late June by a fire at a site in Warwick, Orange County.
