



Grenada energy storage tender announcement

The four projects offered in the tender include the 500-MW Al-Muwyah and 500-MW Haden battery energy storage projects in Makkah province, the 500-MW Al-Khushaybi project in Al-Qassim province and the 500-MW Al-Kahafa project in Hail province. All four batteries will have a storage period of four hours.

A spokesperson for Tesvolt, a German designer and manufacturer battery energy storage systems, told Energy-Storage.news that the demand for large-scale storage systems up to 10MWh is currently increasing. The Innovation Tenders are a significant driver of this demand, along with a growing number of hydrogen projects.

The UK's buoyant BESS market kicked things off with a 200MW competitive solicitation for ancillary services in 2016, while more recently the Australian government has committed to rolling out tenders for dispatchable low carbon energy that could only be achieved with the involvement of energy storage resources.

The New South Wales (NSW) government's largest energy storage tender in the state's history has now opened, offering support for up to 1 GW of projects that can each release energy into the state's grid for at least eight hours, equivalent to the daily energy consumption of 505,000 houses.. Over a gigawatt of bids from battery storage project developers have been successful in the first-ever competitive auctions for low-carbon energy capacity held in Japan. A total 1.67GW of projects won contracts, including 32 battery energy storage system (BESS) totalling 1.1GW and three pumped hydro energy storage (PHES) projects totalling 577MW.

According to an announcement made by Bulgaria's Ministry of Energy, the tender will also include 150MW of storage capacity. The main objective of the tender round is to encourage contributions to increase the share of clean energy in Bulgaria's energy mix on the way to climate neutrality.

A total of 4,000MWh of pilot tenders for standalone energy storage are expected to be launched in total by the government of India.
