Battery storage and solar are great ways to ditch utility bills and become energy independent - but are batteries eligible for the solar tax credit? As a result of the signing of the Inflation Reduction Act, the 30% Residential Clean Energy Credit became immediately effective.

Normally a solar system of this size would cost around \$16,740 in Hawaii. Thanks to the 30% federal tax credit and the Hawaii income tax credit (\$5,000), the net system cost is reduced to only \$6,718.
