Does Italy need an efficient energy storage system?

These targets cannot be achieved without implementing an efficient energy storage system in Italy. Italy's growing need for storage systems is particularly evident in Central and Southern Italy, where a large number of renewable energy plants have been installed.

What is the EU state aid scheme for energy storage in Italy?

The European Union (EU) Commission has approved a state aid scheme aiming to fund the rollout of over 9GW/71GWh of energy storage in Italy. The scheme totalling EUR17.7 billion (US\$19.5 billion) will provide annual payments covering investment and operating costs for those developing, building and operating large-scale energy storage in Italy.

Are battery energy storage systems needed in Italy?

Therefore, battery energy storage systems (BESS) are needed in Italy. The Italian market for BESS is growing rapidly and currently amounts to 2.3 GW but it almost exclusively consists of residential scale systems, associated with small scale solar plants, having a capacity of less than 20 kWh.

How will Italy develop utility-scale electricity storage facilities?

To develop utility-scale electricity storage facilities, the Italian Government set up a scheme that was approved by the European Commission at the end of 2023. Italy will promote investments in utility scale electricity storage to reach at least 70 GWh, and worth over Euro 17 bn, in the next ten years.

Are energy storage facilities regulated in Italy?

The Italian regulatory framework concerning energy storage facilities has been evolving rapidly in recent years. However, the legislation is relatively fragmented, given the high number of laws governing different aspects of energy storage facilities.

New Italian regulation and tax duties. Italian Energy Storage. In order to meet the European Union's energy and climate greenhouse gas emissions targets by 2030, EU countries need to establish a 10-year integrated national energy and climate plan to cover the period between 2021 and 2030.

The grid-scale Italian energy storage market has been kickstarted from two different directions. The first was big wins for battery storage projects in ancillary service and capacity market auctions by Terna, in 2020 and 2022, respectively. The second is a policy recognition from Terna that energy storage will be

managed by the Italian Energy Market Operator (GME), involving Terna and operators interested in utilizing storage capacity, but not directly the managers of the storage systems themselves, who are simply obligated to make their capacity available. Specifically: - GME manages the market platform for purchasing such products

The new market rules will allow grid operator Terna to run large-scale energy storage auctions. In particular, for the Italian case, there are no specific regulation regarding any kind of energy storage. Currently, the energy storage systems connected to the grid have to respect the relative regulation for the connection of a generator to the distribution grid (CEI 0-21 for LV connection and CEI 0-16 for MV and HV connection).

Figures by industry group Italia Solare put the current size of the Italian energy storage sector at approximately 450MW of total installed capacity.
