How many JCM projects are selected for fy2023?

On February 2,2024, Ministry of the Environment (MOE), Japan, announced fivenew projects selected for the JCM Model Projects of the Joint Crediting Mechanism (JCM) Financing Support Programme for FY2023 (third round) in addition to the four projects in the first round (August 17,2023) and the four projects in the second round (October 5,2023).

How does Moe Japan promote decarbonizing infrastructure?

MOE Japan will continue to strongly promote the overseas expansion of decarbonizing infrastructure through the JCM,based on the "Plan for Global Warming Countermeasures (Cabinet decision in October 2021)" and others. 1. JCM Outline - Since 2013,Japan has established the JCM with 28 partner countries,and over 200 projects have been selected.

When will CCS projects be covered in JCM?

Toward the start of CCS projects in JCM, JCM Rules & Guidelines is being revised starting in 2021so that CCS projects will be covered in JCM. Additional items for the "CCS Rules & Guidelines" have been already extracted. Based on these results, specific requirements are currently being considered. The Rules & Guidelines will refer ISO27914/27916.

Are CCS projects covered in JCM-Redd+ documents?

However, CCS projects are not covered in these documents. On the other hand, in the JCM with Cambodia and Lao PDR, additional documents have been developed for REDD+projects. The red part indicates that a new institutional document has been established for JCM-REDD+.
