Will the Supreme Court review the lithium-ion batteries antitrust lawsuit?

On November 16,2022,the Ninth Circuit Court of Appeals rejected one objection related to the \$113 million in settlements obtained in the Lithium-Ion Batteries Antitrust Litigation. The objector has until February 14,2023 to file a petition asking the Supreme Court to review this decision.

When will class members get paid for a lithium-ion battery lawsuit?

Class members should begin receiving their payments for the Lithium-Ion Batteries Antitrust Litigation in the coming weeks. On November 16,2022,the Ninth Circuit Court of Appeals rejected the one objection related to the \$113 million in settlements.

What's going on with lithium-ion cylindrical batteries?

A \$64.45 million settlement has been reached in a class action lawsuit filed by indirect purchasers of certain products containing lithium-ion cylindrical batteries who allege the defendants and co-conspirators unlawfully conspired to fix, raise, maintain or stabilize the prices of the batteries.

What is a Li-ion battery lawsuit?

What is the case about? The lawsuit alleges that defendants and co-conspirators conspired to raise and fix the prices of cylindrical li-ion cells for more than ten years, resulting in overcharges to indirect purchasers of portable computers, camcorders, and power tools containing li-ion cylindrical batteries.

Did lithium-ion batteries violate antitrust laws?

The plaintiffs claim that the world's largest manufacturers of lithium-ion batteries violated federal and state antitrust, unfair competition and consumer protection laws by scheming to raise and fix the prices of cylindrical lithium-ion cells for more than a decade.
