Solar energy is the largest source of renewable energy in New Jersey, accounting for 80% of the clean energy generated. New Jersey's Energy Master Plan aims to make the Garden state energy clean by 2050, with 2,000 megawatts of energy storage installed by 2030.

There are currently four solar incentives available to homeowners in New Jersey. The first solar incentive is the investment tax credit (ITC), which currently allows you to deduct 30 percent of the cost of your solar energy system from your taxes. The second incentive is the Solar renewable Energy Certificate (SREC) program, followed by sales tax exemption and property tax exemption.

New Jersey's Board of Public Utilities is creating an energy storage incentive to make installing solar batteries more affordable. Plus, the state is expanding community solar programs to ...

New Jersey solar sales tax exemption: You don't need to pay any sales tax on solar energy equipment in New Jersey, saving at least 6.625% of your system costs. New Jersey solar property tax exemption: If you use solar energy as a source of power, you won't need to pay more for the value your solar panels add to your property.

Remember, these SREC-II earnings are in addition to the energy savings and increased home value from going solar and can substantially increase your return on investment.. Sales and property tax exemptions. New Jersey has two solar incentives in the form of tax exemptions. First, there is a sales tax exemption for the 6.625% state sales tax rate.
