Does Oregon offer solar incentives?

Yes, Oregon offers solar incentives. In addition to solar incentives, Oregon also offers some great battery incentive programs to bring down the price of energy storage. For instance, you can get a rebate worth up to \$2,500 for your battery with the Oregon Solar +Storage Rebate Program.

#### Can I subscribe to a community solar project?

If you're a customer of Portland General Electric, Pacific Power or Idaho Power, you can subscribe to a community solar projectand receive credits back on your utility bill.\* Households meeting low-income guidelines receive subscription discounts and guaranteed savings.

#### Can I get Utility bill credits for a community solar project?

At PacifiCorp Sites, you can receive utility bill credits in exchange for buying or leasing part of a community solar project. Thinking of installing solar panels or other renewable power systems? Make us your first stop.

#### How do I get a credit for a community solar project?

#### Who is eligible for the Oregon community solar program?

Establish your eligibility Oregon customers of Pacific Power,Portland General Electric and Idaho Powerare eligible to participate in the Oregon Community Solar Program. You can participate if you are a resident (whether you own,rent or live in a single-family,multifamily or manufactured home) or a business (whether you own or rent your space).

#### Is installing solar panels tax deductible?

Installing solar panels might make you eligible for a tax creditif you're a tax-exempt entity, like a nonprofit organization. The ITC (Investment Tax Credit) does not provide a direct payment, but you can deduct the cost of the solar panels and related equipment from your federal taxes. If you add a battery to your solar panel system, you can receive a rebate of up to \$5,000 for your solar panels and up to \$2,500 for your battery.

Qualifying Pacific Power customers will receive \$1.00 per Watt discount on their solar installation with a maximum discount of \$6,000 per home. Battery Incentive. If you"re a Pacific Power customer, you can earn \$1,000/kW for solar, up to \$6,000, and \$750/kWh for storage, up to \$10,000. Local rebates. Two local electric companies and one city in Oregon offer rebates when you install solar panels:

Incentives are capped at 70% of the energy efficiency project costs and incentives will not be available to reduce the energy efficiency project simple payback below one year. Energy savings and energy efficiency project costs are subject to Pacific Power approval.

What incentives, tax credits, and rebates are available to Pacific Power customers for installing solar? The biggest financial incentive for solar homeowners is the 30% federal solar tax credit. The tax credit equals 30% of the solar installation costs and directly reduces your federal income tax liability.
