To protect consumers in Pennsylvania, Attorney General Josh Shapiro launched an investigation into Power Home Solar, who also does business as Pink Energy, after receiving complaints regarding the company's alleged deceptive business practices.

Pink Energy is facing an investigation from the Missouri Attorney General"s Office, which issued an investigative demand for information "regarding its practices for sales and installation of solar panels." There are more than a dozen lawsuits filed against Pink by customers and subcontractors in 2022 alone.

Waller also claimed the issues with panels underdelivering were because of a malfunctioning battery that was supplied by another company for the solar panel projects.
