

Will Poland increase subsidy levels for PV & storage installations?

Poland 's government has revealed that it will increase subsidy levels for residential PV and storage installations under the Mój Pr?d (My Electricity) rebate scheme. As of Dec. 15, the subsidy for solar will be raised from PLN 4,000 to PLN 6,000.

Will Poland raise solar subsidy levels in December?

The Polish government will raise subsidy levels for rooftop PV and storage systems from Decemberunder its Mój Pr?d scheme. The rebate for solar will increase from PLN 4,000 (\$888) to PLN 6,000 and will more than double from PLN 7,500 to PLN 16,000 for storage.

How much is solar subsidy in PLN?

As of Dec. 15,the subsidy for solar will be raised from PLN 4,000 to PLN 6,000. The rebate for storage will more than double from PLN 7,500 to PLN 16,000,according to the scheme's website. The scheme is open to residential rooftop PV projects ranging in size from 2 kW to 10 kW,and storage installations from 2 kWh.

How much subsidy is available for solar installations?

The maximum subsidy available for solar without storage is PLN 6,000,increasing to PLN 7,000 for solar micro-installations with storage. Any solar installations connecting to the grid after Aug. 1 must be paired with electric storage facilities and/or heat storage facilities to be eligible. The installations can range from 2 kW to 20 kW in size.

A new subsidy scheme for residential solar-plus-storage installs is now live in Bavaria. The state in southern Germany will provide EUR500 (US\$550) for a storage system of at least 3kWh and a further EUR100 (US\$110) for each additional 1kWh up to a maximum of EUR3200 (US\$3530). The storage system must be paired with a solar installation.

The subsidy for renewable new energy in 2021 was 1.32 billion Euros, of which 220 million Euros are for energy storage subsidies. Households can receive a 70% credit for energy storage purchase costs. Poland Yes Yes VAT is reduced from 23% to 8%, and the purchase cost can be deducted from income tax, up to PLN 53,000 (EUR11,000).

With the successful implementation of the first iteration subsidy policy, the next iteration's goals, new requirements, and the forecast standards it aims to reach.
