At FedEx, we have a robust system in place to mitigate risks with lithium battery shipments. We support the harmonization of US law with the International Civil Aviation Organization rules for lithium batteries. A global set of rules should be applicable to this inherently global product.

How much lithium battery can you ship on FedEx Ground?

FedEx Ground has higher allowances, with up to 70kg permitted for larger standalone battery shipments. It's important to stay within these limits, as quantity violations are a leading cause of lithium battery shipping fines and penalties.

Can I ship a lithium battery cross-border?

There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries. Lithium batteries, for example, are classified as Dangerous Goods, so not all types of lithium batteries are accepted by DHL Express which you can check here.

What is a FedEx declaration for lithium battery air shipments?

This is a legal document where the shipper certifies that the batteries have been properly classified, packaged, marked, and labeled. FedEx Express requires a hardcopy declaration with red hatchings for standalone lithium battery air shipments. FedEx Ground accepts electronic declarations for these shipments.

What types of batteries does FedEx accept?

FedEx accepts two main categories of lithium batteries: Lithium ion (Li-ion) batteries and cells: These are rechargeable batteries commonly found in consumer electronics like cell phones, tablets, laptops, and digital cameras. They're also used in some medical devices, power tools, and electric vehicles.

Do I need a specific lithium battery Shipping Class?

FedEx Ground strongly recommends that anyone shipping lithium batteries take a specific lithium battery shipping class in order to better understand these complex regulations and meet DOT/ICAO/IATA/IMDG/USPS requirements.

For shipping, all types of lithium batteries are classified as dangerous goods -- with special regulations for packing, labelling, documentation and handling. ...
