Shipping lithium batteries to hawaii usps

Can I ship lithium batteries overseas?

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

Can I ship lithium batteries via USPS?

#1:Yes,you can ship lithium batteries via USPS. However ...There are currently six types of lithium batteries eligible for shipment,in varying domestic or international quantities,via USPS: Don't forget the new lithium battery marks that became mandatory this year!

Are lithium ion batteries safe to ship to Hawaii?

Per UPS guidelines, air shipments must also include the following statement: "Lithium ion battery - PI 965, Section II". Properly packaged and labeled lithium battery shipments comply with national and airline regulations, ensuring safe transit to destinations like Hawaii.

How do I ship a lithium battery?

USPS has official instructions and guidelines for shipping batteries. ShipSaving helps you to highlight the following information: All packages containing lithium metal or lithium-ion batteries that can be mailed must be of sufficient size, sealed, and rigid. This ensures that the lithium battery mark can be affixed to the address without folding.

Do I need a specific lithium battery Shipping Class?

FedEx Ground strongly recommends that anyone shipping lithium batteries take a specific lithium battery shipping class in order to better understand these complex regulations and meet DOT/ICAO/IATA/IMDG/USPS requirements.

What is a bill of lading for lithium battery shipments to Hawaii?

For lithium battery shipments to Hawaii,the bill of lading must clearly identify the batteries and quantity,and indicate they are fully regulated Class 9 hazardous materials. The document helps ensure all cargo handlers are aware of the shipment contents and any risks.

USPS Packaging Instruction 9E Lithium Metal and Lithium-ion Cells and Batteries -- International and APO/FPO/DPO. Lithium metal (non-rechargeable) cells and batteries and lithium-ion (rechargeable) cells and batteries are mailable in limited quantities internationally or to and from APO, FPO, or DPO locations only when they are properly installed in the equipment they operate.

Also, while I was just at the post office, I asked about the air-shipping restrictions for items with batteries, and I specifically asked if it was just for Lithium-ion batteries, and she said that this restriction applies for any type of battery.

One example of a tool like this is an electric drill. That isn"t necessarily a problem when it comes to sending them with USPS, but you should know that shipping packages with lithium ion batteries requires a different process than others. When shipping lithium ion batteries, you"ll need to affix special labeling to the outside of your package.

USPS Packaging Instruction 8B Nonspillable Wet Battery. A nonspillable wet battery containing liquid electrolyte is prohibited from mailing unless the battery casing is completely sealed to prevent the liquid corrosive from spilling during handling, as allowed in 348.Nonspillable batteries with UN2800 are prohibited in international mail, but they may be sent as domestic mail via air ...

USPS Packaging Instruction 9D Lithium Metal and Lithium-ion Cells and Batteries -- Domestic. Except according to 349.21, lithium metal (nonrechargeable) cells and batteries and lithium-ion (rechargeable) cells and batteries are mailable in limited quantities domestically via air or surface transportation when they are installed in or packed with the equipment they are intended to ...

Can confirm. Recently went through this with UPS and they sent back a package that contained batteries that was shipped via Ground Service. UPS will however allow batteries to be shipped to Hawaii via 2nd-day air or next-day air as long as the package is properly marked with those lithium ion battery stickers.

Regulations differ when shipping by air (this includes FedEx Ground shipments to Alaska and Hawaii), water or USPS/SmartPost service. FedEx Ground strongly recommends that anyone shipping lithium batteries take a specific ... regulations for shipping lithium batteries found in 49CFR173.185 for the most updated information. Lithium batteries can be shipped domestically including Hawaii and Alaska but there are different requirements to ship domestically and internationally via air. There is a greater chance of lithium batteries exploding or being damaged during transport so using a reputable carrier that has guidelines for shipping them is recommended.
