Solar company liquidation



Is SunPower a liquidation?

Despite filing for Chapter 11, which typically allows a company to restructure rather than liquidate, SunPower's situation looks like a liquidation. In July, the company paused several key operations, including new product shipments and leasing and purchasing agreements. This pause signaled growing difficulties within the company.

Why did complete solar file for bankruptcy?

The company filed for Chapter 11 Bankruptcy, which allows a company to restructure while it continues to operate. Complete Solar, acting as a "stalking horse buyer," was awarded the bid for a portion of SunPower's assets, including Blue Raven Solar, SunPower's New Homes business, and a portion of SunPower's Dealer network.

Do solar companies go out of business?

Why did vision solar go out of business?

Vision Solar: After its sales tactics came under scrutiny, Vision Solar declared bankruptcy at the end of 2023. The company was being sued by Connecticut and other states when it went out of business.

How did SunPower's bankruptcy affect the solar industry?

Even before the bankruptcy filing, SunPower ceased solar lease and PPA offerings, creating problems that reverberated through the industry. The effects trickled down to dealers and installers like Renova Energy, a major SunPower partner that services the Nevada and California markets and maintains an excellent 4.9-star rating on SolarReviews.

Why did Empire solar go out of business?

In August of 2021, Empire Solar went out of business and filed for Chapter 7 bankruptcy protection, with former employees bringing a class-action lawsuit against the company's founders.

In February 2024, the company raised \$8 million in seed funding to boost its new climate fintech strategy, focusing on tech advancements, product innovation, and solar installer skill development. Meanwhile, Hohm's parent company, Spark Energy, clarified that there was a misunderstanding regarding the capital raise.

A developer of solar panel technologies needed to raise an additional \$300,000 in capital to continue R& D on their solar technologies as well as cover the company's expenses. Understanding that traditional venture capital fundraising can take from six months to a year, the company's time horizon was much shorter.

On August 5th, 2024, SunPower Corporation announced it had filed a Chapter 11 bankruptcy petition in the District Court of Delaware, which included nine of its affiliates. The announcement came just 19 days after the company stopped supporting all lease and power purchase agreements (PPAs) and 103 days after it announced massive layoffs and the end of its direct ...

Empire Solar Group: Founded by Abby Buchmiller and Amanda Roseburg, Empire Solar Group was a female-led solar company that had a dealer-based Engineering, Procurement, and Construction (EPC) model operating out of 14 states, and was worth over \$150M at its peak.
