Does Florida have a solar rebate program?

Compared to some other states,such as New Jersey,Florida doesn't have many strong solar incentives. It does not have a direct solar rebate program. The only incentive that should play a notable role in your consideration of solar panels is the federal solar tax credit.

Does Florida offer solar incentives?

The state encourages its residents to install solar panels,although it doesn't rank in CNET's list of seven best states for solar incentives. Florida is one of only three states that offer property-assessed clean energy loans for solar.

Does Florida have a sales tax exemption for solar panels?

Since you don't have to do anything to claim it,the sales tax exemption is a great benefit program to claim,as it reduces the all-in cost of installing a solar energy system. Florida's sales tax is currently 6%,so it can save you well over \$2,000 depending on how many solar panels your system needs.

How much does solar cost in Florida?

With just one tax credit,the average effective cost of solar panels can drop from \$34,960 to a much more reasonable \$24,472. The average system price of solar in Florida is above the national average,and the incentives aren't as appealing as they are in many other states -- likely because the state has no Renewable Portfolio Standard (RPS) goal.

What's going on with Florida's solar policy?

Some critics have challenged solar policies in Florida. The state legislature passed a law in 2022 to end net metering but was rebuffed by the governor's veto. PACE loans have come under fire for their lack of transparency. It's more important than ever for Floridians to know what's going on with solar panel incentives in their state.

Does Florida have incentive programs?

Because of the program's success,it later expanded to the rest of Florida. As of 2024,Florida does not have incentive programscovering specific regions or cities,beyond the statewide programs discussed above. So you will not qualify for additional incentives just for living in Orlando or Tampa,for example.

While some programs are available to all Florida residents, others vary by city, municipality, and utility company. You must purchase your system outright or choose a solar loan to qualify ...

Federal Tax Credits Federal Solar Tax Credit. Florida residents can additionally benefit from federal incentives and tax credits. The Inflation Reduction Act of 2022 introduced the federal solar tax credit, or investment tax credit (ITC), available to all U.S. homeowners. This program provides a 30% tax credit for solar systems installed between 2022 and 2032.

These tax credits provide a dollar-for-dollar reduction in federal income taxes based on the cost of installing a solar energy system.

Find Energy data states the average price per watt in Florida is \$3.12 with an average system size of 9 kilowatts (kW). According to the Lawrence Berkeley National Laboratory, this is lower than the national average of \$3.67 per watt with the US average system size of 8.6 kW, making the average nationwide total cost of solar \$31,558.
