

The latest summary of energy storage standards

What is the energy storage technology standard?

Applying to all energy storage technologies, the standard includes chapters for specific technology classes. The depth of this standard makes it a valuable resource for all Authorities Having Jurisdiction (AHJs).

Does industry need energy storage standards?

As cited in the DOE OE ES Program Plan, "Industry requires specifications of standards for characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry professionals indicate a significant need for standards ..." [1, p. 30].

What's new in energy storage safety?

Since the publication of the first Energy Storage Safety Strategic Plan in 2014, there have been introductions of new technologies, new use cases, and new codes, standards, regulations, and testing methods. Additionally, failures in deployed energy storage systems (ESS) have led to new emergency response best practices.

Are energy storage codes & standards needed?

Discussions with industry professionals indicate a significant need for standards..." [1, p. 30]. Under this strategic driver, a portion of DOE-funded energy storage research and development (R&D) is directed to actively work with industry to fill energy storage Codes & Standards (C&S) gaps.

Can energy storage systems be scaled up?

The energy storage system can be scaled up by adding more flywheels. Flywheels are not generally attractive for large-scale grid support services that require many kWh or MWh of energy storage because of the cost, safety, and space requirements. The most prominent safety issue in flywheels is failure of the rotor while it is rotating.

Is DOE addressing the energy storage industry's challenges?

EAC conducted a months-long review of obstacles and challenges facing the energy storage industry to determine areas of pressure and pain, and to assess whether DOE was addressing these obstacles and challenges in its funding, policy, initiatives, and other efforts.

The Office of Electricity's (OE) Energy Storage Division's research and leadership drive DOE's efforts to rapidly deploy technologies commercially and expedite grid-scale energy storage in meeting future grid demands. The Division advances research to identify safe, low-cost, and earth-abundant elements for cost-effective long-duration energy storage.
